TERMS & CONDITIONS as of March 3, 2020

1. **As per Heading 9985 Services by an Organizer to any person in respect of a business exhibition outside India – GST Nil.**
 2. Investment at INR 11.0 lakhs for 100 sq. feet for the Exhibition booth and access to Exhibition area. **Corner Booths 1747 D, 1847 C, 1753 B, 1853 A will cost 11.5 lakhs.**
 3. **50 sq. feet Booths at 5.75 lakhs subject to availability and finding a second exhibitor to share the 100 sq. feet.**
 4. Fully furnished Booths with electricals and carpeting with standard furniture.
 5. The 1400 sq. ft. INDIA Pavilion (**Booth #s 1747, 1753, 1847 of 400 sq. feet and Booth 1853 of 200 sq. ft. are divided into Booths of 100 sq. feet each**) and the Booths are being structured to give the Exhibitors the best possible exposure.
 6. LCD in the Booth can be provided on advance payment. In 2019 the rate was 52,542. PI check 2020 rates with us.
 7. Conference sessions Access will need an additional fee that should be purchased directly from BIO through online. The Convention Access is required for access to the various conference sessions. The 5.75/11.0/11.5 lakhs does NOT include conference access registration. Please Click for 2020 conference registration rates and eligibilities.  8. Please apply at the earliest. 100% advance will be required to be paid to ABLE at the time of booking. Confirmation only on receipt of entire amount by ABLE. No part or conditional payments accepted. First pay First Confirmed principle will be applied.
 9. After Confirmation – there will be no refund for any reason including denial or delays in obtaining US Visa.
 10. In case of No Show or delays in providing final Poster/logo Files in the required format as per communicated deadlines, ABLE will have a right to cancel a confirmed Booth (without refund) in order to prevent potential adverse impact on ABLE, India Pavilion and other exhibitors. Deadline for poster files is March 21, 2020
 11. 100 sq. feet Exhibitor provided a total of 5 EBP (Exhibitor Booth Personnel) passes allowing access to Exhibition. 50 sq feet exhibitors to be provided 2 EBP passes. One of the EBP passes to be utilized for the InBooth Partnering account of the exhibitors.
 12. Maximum of one InBooth partnering Accounts allowed per exhibiting Organization to invite and accept meeting requests. In Booth partnering to be provided at 10 identified spots. The schedule and location of meetings to be decided by the BIO Partnering system for which the requests must be made by the Exhibitor well in time. The location of the meeting spot may not be in your booth but close by, within the India Pavilion. Meetings can also happen in your invitee's Pavilion. Responsibility of ABLE ends with providing the Partnering Account.
 13. Exhibitor team is also Invited to India related sessions at BIO and other events if the sessions do not require Conference Access passes.
 14. Profile included in the Exhibitor Brochure provided all information requested is supplied by March 30, 2020.
 15. Trip to Local industries/companies/laboratories may be arranged by BIO. Fees will be payable to BIO directly for which the exhibitor team members will have to register online individually.
 16. Interaction with other Country delegations as per finalized program and availability.
 17. Access to various events in the Exhibition area normally provided by BIO to Exhibitor Booth Personnel as per information in the PDF on the BIO website.
 18. **Exclusions:** No charge/liability can be created on ABLE if any Exhibitor avails services from any Service provider at the venue. Exhibitor will be solely responsible to discharge all liabilities unless explicitly mentioned by ABLE.
 19. No infants or persons below 21 years are allowed in the Venue at any time during the Convention or Exhibition.
 20. Any or all Terms and conditions can be altered by ABLE as per changes communicated by BIO or the Department of Biotechnology or the Government of India and the ground realities. The latest terms and conditions will apply.
