- EXHIBITOR:** Any Company / Organisation participating in Global Bio-India (GBI) 2019
- EXHIBITOR ELIGIBILITY:** Companies, Organisations working in the sphere of Biotechnology and associated sector and services. Organisers reserve the right of participation.
- Participation in the exhibition will include complementary delegate registration for the conference for 1 person for stall size 9 – 21 sqm., 2 people for stall size 24 – 30 sqm. 3 for stall size 36 – 48 sqm and 5 for 50 sqm & above.

- Application for space may be made in combinations / multiples of contiguous plots / booths. For a combination of contiguous, furnished standard booths allotted, provision of partitions within the area would be optional.

- For allotted raw space, the exhibitor will have to erect their stand at their own cost in line with the "Rules & Guidelines for Design and Construction of Stand" for GBI 2019.
