








BIO, SAN DIEGO, CA, USA. June 3 – 6, 2024

Government, Public Sector, and Private (Startups, SMEs & larger companies), to participate as Exhibitors in the India Pavilion and reach out to the Global market.







EXHIBITOR ENTITLEMENTS:

- 1) Fully furnished booths with electrical, carpeting, standard furniture as per the booth types mentioned above and with Full Access to the Exhibition area.
- 2) Each Booth Type 'A' exhibitor will be provided with a total of **one Exhibitor**Booth Personnel (EBP) Badge and **one Exhibitor Booth Partnering Badge**(EPA) allowing access to the Exhibition area.
- 3) Each Booth Type 'B' 'C' and 'D' will be provided with **four Exhibitor Booth Personnel (EBP) badges** and **one Exhibitor Booth Partnering (EPA) Badge**allowing access to the Exhibition area.
- 4) Only one Exhibitor Booth Partnering Badge is allowed per exhibitor (irrespective of the type of the booth) to send invites and accept meeting requests.
- 5) Access to various events in the Exhibition area is normally provided by BIO to Exhibitor Booth Personnel.
- 6) Exhibitor team is also invited to India-related sessions at BIO and other events if they do not require Conference Access passes.
- 7) A brief profile of the Exhibitor in the Exhibitor Brochure / India Biotech Handbook 2024.
- 8) Interaction with other Country delegations as per finalized program and availability.

GOVERNMENTAL SUPPORT FUNDING:

- Market Access Support provided by various States under its Startup Policy can be utilized by DPIIT registered Startups to get booth, airfare and accommodation cost reimbursed as per each state Startup Policy guidelines. Assistance will be provided in terms of preparing required documentations.
- 2) Indian MSMEs participation is supported by Ministry of Micro, Small and Medium Enterprises, Government of India to reimburse exhibit cost, airfare, and freight cost as per MSME guidelines.

PAYMENT TERMS:

1) 100% payment must be paid within 15 days from the date of confirmation.

No part or conditional payments are accepted.

- 3) The amount paid will not be refunded for reasons whatsoever including denial or delays in obtaining a US Visa.
- 4) In case of No Show or delays in providing the final posters/logo files in the required format as per communicated deadlines, ABLE will have a right to cancel a confirmed booth (without refund) to prevent potential adverse impact on ABLE, India Pavilion, and other exhibitors.





OTHER TERMS & CONDITIONS

- 1) ABLE reserves full right to change the floor plan, increase or decrease the number & type booths and allotment of booth to the exhibitor.
- 2) The Exhibitor booth charges mentioned above do **NOT** include access to Conference sessions. Access to the conference will need an additional fee that should be purchased directly from BIO by separate registration.
- 3) Trip to Local industries/companies/laboratories may be arranged by BIO. Fees will be payable to BIO directly for which the exhibitor team members will have to register online individually.
- 4) Booth partnering to be provided at 10 identified spots within the India Pavilion. The schedule and location of meetings to be decided by the BIO Partnering system for which the requests must be made by the Exhibitor well in time. The location of the meeting spot may not be in your booth but close by, within the India Pavilion. Meetings can also happen in your invitee's Pavilion. Once the invitee reaches the meeting spot the exhibitor can easily take him to his or her own booth. The responsibility of ABLE ends with providing the Partnering Account.
- 5) Trip to Local industries/companies/laboratories may be arranged by BIO. Fees will be payable to BIO directly for which the exhibitor team members will have to register online individually.
- 6) The last date to provide the posters/logo files and information for Booth and for Indian Biotech Handbook is 31st March 2024.
- 7) Additional printing charge of US \$1500 equivalent in INR + GST will be charged per graphic panel to be displayed in the booth if submitted after the due date i.e. 31st March 2024.
- 8) Exclusions: No charge/liability can be created on ABLE if any Exhibitor avails services from any Service provider at the venue. Exhibitors will be solely responsible to discharge all liabilities unless explicitly mentioned by ABLE.
- 9) No infants or persons below 21 years are allowed in the Venue at any time during the Convention or Exhibition.





- 10) Any or all Terms and conditions can be altered by ABLE as per changes communicated by BIO or the Government of India and the ground realities.

 The latest terms and conditions will apply.
- 11) ABLE will not be liable for any mishaps due to Force Majeure or events beyond its control.
