## GENERAL EXHIBITION RULES

1. **ORGANISER:** Confederation of Indian Industry (CII), 23, Institutional Area, Lodhi Road, New Delhi 110001, India on behalf of Department of Biotechnology (DBT), Government of India and Biotechnology Industry Research Assistance Council (BIRAC), Government of India

2. **VENUE:** Aerocity (Near Airport) New Delhi, India

3. **EXHIBITION TIMINGS:** 1000 – 1800 hrs

4. **EXHIBITOR:** Any Company / Organisation participating in Global Bio-India (GBI) 2019

5. **EXHIBITOR ELIGIBILITY:** Companies, Organisations working in the sphere of Biotechnology and associated sector and services. Organisers reserve the right of participation.

6. Participation in the exhibition will include complementary delegate registration for the conference for 1 person for start-up stall size 1 – 2 sqm.

7. Participation in the exhibition entitles one representative from participating organisation to register for Bio-partnering (B2B) platform.

### Notes:

a) Allotment of the stall will be on “first-come-first-serve” basis strictly subject to availability of space and on receipt of payment.

c) Rental includes 1 / 2 passes for exhibitor staff manning stands during the Fair and one free entry in the exhibitor catalogue

e) The organisers reserve the rights to reallocate space, change the layout / add or delete corridors in space plans, which may affect some exhibitors’ stand orientations. The organiser decision shall be final.

f) The Organisers reserves the right to turn down the application for participation, or even deny participation to exhibitors already confirmed. The Exhibitor shall not organise any concurrent shows outside of GBI 2019 in New Delhi.

g) The Exhibitor company / organisation participating in GBI 2019 enters into a contract upon submission of this document. The proposed exhibitor agrees to participate at GBI 2019 and abide by the rules and regulations of GBI 2019 & byelaws, handed out by organisers to the company, before the exhibition.

h) Upon any breach of contract by the company / organisation (proposed exhibitor), the organisation is liable to pay the space rentals in full to the organiser.

10. **CANCELLATION:** If the exhibitor withdraws from this contract after having concluded the said contract, the exhibitor hereby agrees to indemnify the Organiser for the losses. 100% cancellation charges would be applicable on cancellation of the booking.

12. **DAMAGES:** Exhibitor will be required to make payment for all damages or make good all damages to the venue facilities / buildings etc., incurred during setting-up exhibition duration and / or dismantling period.

13. **SALE OF EXHIBITS:** No sale of Exhibits is allowed during exhibition period.

14. **REMOVAL OF ANY EXHIBIT:** During the exhibition period is prohibited. Exhibits to be removed after 1800 hrs inwards on closure of the show on 23 / 11 / 2019 and to vacate the stands by 0600hrs of 24 / 11 / 2019. Organiser will not be responsible if exhibitors fails to comply with this date.

15. **HANDLING OF EXHIBITS ON CUSTOMS AND IMPORT PROCEDURES:** The ORGANISER will appoint official clearing and freight forwarding agencies for GBI 2019, who will assist in handling and completing customs formalities on payment, if required. Exhibitors would have to contact them directly for such assistance. Movement of exhibits in the Exhibition halls by agencies other than the official clearing and forwarding agents are strictly prohibited.

20. **INSURANCE:** Against all ascertainable risks – from transportation to display and removal – should be done by the exhibitors at their cost. Organiser will in no way be responsible.

21. **PHOTOGRAPHY / VIDEO:** The Organiser reserves the right for photography / video shooting of any stand / exhibit for their use.

22. **SETTLEMENT OF DUES:** Any and all expenses chargeable to an exhibitor must be settled before taking possession of the stall / space to ensure smooth facilitation removal of goods from the exhibition site.

23. **DISPUTE RESOLUTION AND GOVERNING LAW:** All unresolved matters questions, dispute or differences whatsoever arising between the exhibitor and organiser shall be settled by arbitration in accordance with the rules of arbitration and conciliation Act 1996. The arbitration proceedings shall be conducted in English language in New Delhi, India. The arbitration agreement referred to in this paragraph shall be solely and exclusively governed by the laws of India.

24. **FORCE MAJEURE:** If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, national emergency, labour dispute, the non-availability of exhibition premises or any other cause not within the control of the organiser, the organiser may, at their entire discretion, repay the rental paid by the exhibitor, or part thereof, but shall be under no obligation to repay any part of such, rental and shall be under no liability in respect of any actions, claims or losses.
