

- 1. ORGANISER: Confederation of Indian Industry (CII), 23, Institutional Area, Lodhi Road, New Delhi 110001, India on behalf of Department of Biotechnology (DBT), Government of India and Biotechnology Industry Research Assistance Council (BIRAC), Government of India
- 2. VENUE: Aerocity (Near Airport) New Delhi, India
- 3. EXHIBITION TIMINGS: 1000 1800 hrs
- 4. EXHIBITOR: Any Company / Organisation participating in Global Bio-India (GBI) 2019
- 5. EXHIBITOR ELIGIBILITY: Companies, Organisations working in the sphere of Biotechnology and associated sector and services. Organisers reserve the right of participation.
- 6. Participation in the exhibition will include complementary delegate registration for the conference for 1 person for stall size 9 21 sqm., 2 people for stall size 24 30 sqm. 3 for stall size 36 48 sqm and 5 for 50 sqm & above.
- 7. Participation in the exhibition entitles one representative from participating organisation to register for Bio-partnering (B2B) platform.

9. PAYMENT SCHEDULES: 100% payment at the time of booking space (within 7 days of submitting the participation form)

Notes:

- a) The prospective Exhibitor must apply on the Application for Participation (Form1) in GBI 2019 indicating requirement for built-up and / or raw space. Allotment will be on "first-come-first-serve" basis strictly subject to availability of space and on receipt of payment.
- b) Application for space may be made in combinations / multiples of contiguous plots / booths. For a combination of contiguous, furnished standard booths allotted, provision of partitions within the area would be optional.
- c) Rental includes passes for exhibitor staff manning stands during the Fair and one free entry in the exhibitor catalogue
- d) For alloted raw space, the exhibitor will have to erect their stand at their own cost in line with the "Rules & Guidelines for Design and Construction of Stand" for GBI 2019.
- e) The organisers reserves the rights to reallocate space, change the layout / add or delete corridors in space plans, which may affect some exhibitors' stand orientations. The organiser decision shall be final.
- f) The Organisers reserves the right to turn down the application for participation, or even deny participation to exhibitors already confirmed. The Exhibitor shall not organise any concurrent shows outside of GBI 2019 in New Delhi.
- g) The Exhibitor company / organisation participating in GBI 2019 enters into a contract upon submission of this document. The proposed exhibitor agrees to participate at GBI 2019 and abide by the rules and regulations of GBI 2019 & byelaws, handed out by organisers to the company, before the exhibition.
- h) Upon any breach of contract by the company / organisation (proposed exhibitor), the organisation is liable to pay the space rentals in full to the organiser.

- 10. CANCELLATION: If the exhibitor withdraws from this contract after having concluded the said contract, the exhibitor hereby agrees to indemnify the Organiser for the losses. 100% cancellation charges would be applicable on cancellation of the booking.
- 11. APPROVAL FOR DESIGN OF STAND: The Stand design drawings along with to-scale, mock-ups, complete with details of exhibits, electricity, water, telephone and other installation, in 4 copies, should be submitted for Organiser's approval, latest by 5 November 2019. The exhibitor shall be bound by the changes / modifications advised by the exhibition architect, in case of non-receipt of the stand drawings by 10 November 2019, the Organiser is at liberty to allot the stand to another exhibitor. In such an event, the exhibitor is liable to pay for the space rentals in full to the organisers.

- 12. DAMAGES: Exhibitor will be required to make payment for all damages or make good all damages to the venue facilities / buildings etc., incurred during setting-up exhibition duration and / or dismantling period.
- 13. SALE OF EXHIBITS: No sale of Exhibits is allowed during exhibition period.
- 14. REMOVAL OF ANY EXHIBIT: During the exhibition period is prohibited. Exhibits to be removed after 1800 hrs inwards on closure of the show on 23 / 11 / 2019 and to vacate the stands by 0600hrs of 24 / 11/ 2019. Organiser will not be responsible if exhibitors fails to comply with this date.
- 15. HANDLING OF EXHIBITS ON CUSTOMS AND IMPORT PROCEDURES: The ORGANISER will appoint official clearing and freight forwarding agencies for GBI 2019, who will assist in handling and completing customs formalities on payment, if required. Exhibitors would have to contact them directly for such assistance. Movement of exhibits in the Exhibition halls by agencies other than the official clearing and forwarding agents are strictly prohibited.

- 22. SETTLEMENT OF DUES: Any and all expenses chargeable to an exhibitor must be settled before taking possession of the stall / space to ensure smooth facilitation removal of goods from the exhibition site.
- 23. DISPUTE RESOLUTION AND GOVERNING LAW: All unresolved matters questions, dispute or differences whatsoever arising between the exhibitor and organiser shall be settled by arbitration in accordance with the rules of arbitration and conciliation Act 1996. The arbitration proceedings shall be conducted in English language in New Delhi, India. The arbitration agreement referred to in this paragraph shall be solely and exclusively governed by the laws of India.
- 24. FORCE MAJEURE: If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, national emergency, labour dispute, the non-availability of exhibition premises or any other cause not within the control of the organiser, the organiser may, at their entire discretion, repay the rental paid by the exhibitor, or part thereof, but shall be under no obligation to repay any part of such, rental and shall be under no liability in respect of any actions, claims or losses.
